

Game Number 0109 EXTREME GREEN

- 1. The name of Fast Play game number 0109 is "EXTREME GREEN".
- 2. Tickets in Fast Play game number 0109 shall sell for ten dollars (\$10) per ticket, unless otherwise adjusted by temporary price reductions or other promotional activities conducted or authorized by the Commission.
- 3. (a) Each ticket in Fast Play game number 0109 shall contain a total of forty (40) play symbols (twenty-five (25) denoted as "YOUR NUMBERS", ten (10) denoted as "WINNING NUMBERS", and five (5) denoted as a "EXTREME NUMBERS") and a PRIZE LEGEND.
 - (b) Each play symbol is represented as follows:

- 4. (a) To play a ticket in Fast Play game number 0109, the ticket must be validly purchased from a Hoosier Lottery terminal.
- (b) Prizes are dependent on the number of play symbols in the "YOUR NUMBERS" game area that match the play symbols in the game area labeled "WINNING NUMBERS". The "EXTREME BONUS" area is played separately.
 - (1) If exactly one (1) of the play symbols in the "YOUR NUMBERS" game area matches one (1) of play symbols in the game area labeled

- "WINNING NUMBERS", the ticket may be redeemed for ten dollars (\$10).
- (2) If exactly two (2) of the play symbols in the "YOUR NUMBERS" game area match two (2) of play symbols in the game area labeled "WINNING NUMBERS", the ticket may be redeemed for fifteen dollars (\$15).
- (3) If exactly three (3) of the play symbols in the "YOUR NUMBERS" game area match three (3) of play symbols in the game area labeled "WINNING NUMBERS", the ticket may be redeemed for twenty-five dollars (\$25).
- (4) If exactly four (4) of the play symbols in the "YOUR NUMBERS" game area match four (4) of play symbols in the game area labeled "WINNING NUMBERS", the ticket may be redeemed for fifty dollars (\$50).
- (5) If exactly five (5) of the play symbols in the "YOUR NUMBERS" game area match five (5) of play symbols in the game area labeled "WINNING NUMBERS", the ticket may be redeemed for one hundred dollars (\$100).
- (6) If exactly six (6) of the play symbols in the "YOUR NUMBERS" game area match six (6) of play symbols in the game area labeled "WINNING NUMBERS", the ticket may be redeemed for two hundred dollars (\$200).
- (7) If exactly seven (7) of the play symbols in the "YOUR NUMBERS" game area match seven (7) of play symbols in the game area labeled "WINNING NUMBERS", the ticket may be redeemed for five hundred dollars (\$500).
- (8) If exactly eight (8) of the play symbols in the "YOUR NUMBERS" game area match eight (8) of play symbols in the game area labeled "WINNING NUMBERS", the ticket may be redeemed for one thousand dollars (\$1,000).
- (9) If exactly nine (9) of the play symbols in the "YOUR NUMBERS" game area match nine (9) of play symbols in the game area labeled "WINNING NUMBERS", the ticket may be redeemed for five thousand dollars (\$5,000).
- (10) If exactly ten (10) of the play symbols in the "YOUR NUMBERS" game area match ten (10) of play symbols in the game area labeled "WINNING NUMBERS", the ticket may be redeemed for a prize in the amount of the JACKPOT total. The JACKPOT amount will be printed on the ticket and is determined at the time the ticket is printed. The JACKPOT will be at least thirty thousand dollars (\$30,000).
- (c) If a prize is won and one of the "EXTREME NUMBERS" in the "BONUS" play area matches any of the numbers in the game area labeled "YOUR NUMBERS", the ticket may be redeemed for a prize ten (10) times the amount won in the game area above.

- 5. Fast Play game number 0109, "EXTREME GREEN," is not cancellable once printed.
 - 6. (a) The odds for each prize level are as follows:

7. For a Fast Play ticket to be validated, all of the following must be met:

(1) The ticket must be printed on paper stock which was validly issued to and used by the terminal from which the ticket was printed at the time of purchase;

(2) The ticket has not been altered, torn, misprinted, found to be illegible, defaced, or damaged in such a manner that validation is impossible;

(3) The ticket is not counterfeit in whole or in part;

(4) The ticket has not been reconstituted or tampered with in any manner;

(5) The typeface and artwork of play symbols, captions, or characters used as play selections must correspond with the typeface and artwork of play symbols, captions, or characters established by the Commission in these approved Game Rules, working papers, or other specifications applicable to the play of game number 0109;

(6) Each play symbol or character must be present in its entirety and fully legible or the ticket must be capable of being validated via the ticket barcode or transaction number as printed on the ticket; and

(7) The ticket must pass any additional validation test prescribed by the Commission, which for security reasons may be confidential in nature.

8. Fast Play game 0109 has a JACKPOT prize. Ten percent (10%) of each ticket sold funds the JACKPOT which starts at thirty thousand dollars (\$30,000)

and grows with each "EXTREME GREEN" ticket sold. JACKPOT prize winning tickets for Fast Play ten dollar (\$10) "EXTREME GREEN" game number 0109 will be awarded the total JACKPOT.

- 9. Tickets for Fast Play game number 0109 are drawn from a constantly replenished statewide pool of winning and non-winning outcomes based on the established odds. When an outcome, winning or non-winning, is randomly selected from the pool, it is then immediately replaced so the pool size and chance to win each prize remains the same for each ticket.
- 10. Tickets expire 180 days from date of purchase and cannot be redeemed after this date.
- 11. This document expires sixty (60) days after the last claim date established for Fast Play game number 0109.
