


Game Number 0152 SUPER CROSSWORD MULTIPLIER

- 1. The name of Fast Play game number 0152 is "SUPER CROSSWORD MULTIPLIER".
- 2. Tickets in Fast Play game number 0152 shall sell for three dollars (\$3) per ticket, unless otherwise adjusted by temporary price reductions or other promotional activities conducted or authorized by the Commission.
- 3. (a) The game play data area of each ticket in Fast Play game number 0152 shall be divided into four (4) distinct game areas as follows:
 - (1) An area labeled "YOUR 18 LETTERS" that contains eighteen (18) play symbols.
 - (2) A game area composed of a crossword grid that contains a completed crossword puzzle.
 - (3) A game area labeled "BONUS MULTIPLIER" that contains a "BONUS MULTIPLIER" word and a multiplier.
 - (4) An area composed of a "PRIZE LEGEND".
 - (b) The available play symbols are as follows:



- 4. (a) To play a ticket in Fast Play game number 0152, the ticket must be validly purchased from a Hoosier Lottery terminal.
- (b) Prizes are dependent on the number of words formed in the crossword grid using the play symbols in the "YOUR 18 LETTERS" game area. The play symbols in the "YOUR 18 LETTERS" game area must match all of the letters in a

word that appear in the crossword grid in order to form a complete word. Letters combined to form a complete word must appear in an unbroken horizontal or vertical sequence on the crossword grid and in the "YOUR 18 LETTERS" game area. The "BONUS MULTIPLIER" play area is played separately.

- (c) If exactly three (3) complete words are formed in the crossword grid from the play symbols in the "YOUR 18 LETTERS" game area, the ticket may be redeemed for three dollars (\$3).
- (d) If exactly four (4) complete words are formed in the crossword grid from the play symbols in the "YOUR 18 LETTERS" game area, the ticket may be redeemed for five dollars (\$5).
- (e) If exactly five (5) complete words are formed in the crossword grid from the play symbols in the "YOUR 18 LETTERS" game area, the ticket may be redeemed for ten dollars (\$10).
- (f) If exactly six (6) complete words are formed in the crossword grid from the play symbols in the "YOUR 18 LETTERS" game area, the ticket may be redeemed for fifteen dollars (\$15).
- (g) If exactly seven (7) complete words are formed in the crossword grid from the play symbols in the "YOUR 18 LETTERS" game area, the ticket may be redeemed for twenty-five dollars (\$25).
- (h) If exactly eight (8) complete words are formed in the crossword grid from the play symbols in the "YOUR 18 LETTERS" game area, the ticket may be redeemed for one hundred dollars (\$100).
- (i) If exactly nine (9) complete words are formed in the crossword grid from the play symbols in the "YOUR 18 LETTERS" game area, the ticket may be redeemed for one thousand dollars (\$1,000).
- (j) If exactly ten (10) complete words are formed in the crossword grid from the play symbols in the "YOUR 18 LETTERS" game area, the ticket may be redeemed for five thousand dollars (\$5,000).
- (k) If a prize is won in the crossword puzzle and any five (5) of the play symbols in the "YOUR 18 LETTERS" game area matches all five (5) of the letters in the word that appears in the "BONUS MULTIPLIER" with a "(2X), the ticket may be redeemed for two (2) times the amount won in the crossword puzzle.
- (l) If a prize is won in the crossword puzzle and any five (5) of the play symbols in the "YOUR 18 LETTERS" game area matches all five (5) of the letters in the word that appears in the "BONUS MULTIPLIER" with a "(5X), the ticket may be redeemed for five (5) times the amount won in the crossword puzzle.
- 5. Fast Play game number 0152, "SUPER CROSSWORD MULTIPLIER," is not cancellable once printed.
 - 6. (a) The odds for each prize level are as follows:

- 7. For a Fast Play ticket to be validated, all of the following must be met:
- (1) The ticket must be printed on paper stock which was validly issued to and used by the terminal from which the ticket was printed at the time of purchase;
- (2) The ticket has not been altered, torn, misprinted, found to be illegible, defaced, or damaged in such a manner that validation is impossible;
- (3) The ticket is not counterfeit in whole or in part;
- (4) The ticket has not been reconstituted or tampered with in any manner;
- (5) The typeface and artwork of play symbols, captions, or characters used as play selections must correspond with the typeface and artwork of play symbols or characters established by the Commission in these approved Game Rules, working papers, or other specifications applicable to the play of game number 0152;
- (6) Each play symbol or character must be present in its entirety and fully legible or the ticket must be capable of being validated via the ticket barcode or transaction number as printed on the ticket; and
- (7) The ticket must pass any additional validation test prescribed by the Commission, which for security reasons may be confidential in nature.
- 8. Tickets for Fast Play game number 0152 are drawn from a constantly replenished statewide pool of winning and non-winning outcomes based on the established odds. When an outcome, winning or non-winning, is randomly selected from the pool, it is then immediately replaced so the pool size and chance to win each prize remains the same for each ticket.
