1. The name of the scratch-off game number 2164 is "BINGO FRENZY".
2. Tickets in scratch-off game number 2164 shall sell for two dollars (\$2) per ticket, unless otherwise adjusted by temporary price reductions or other promotional activities conducted or authorized by the Commission.
3. Scratch-off game number 2164 includes four (4) separate and independent game areas labeled "CARD 1", "CARD 2", "CARD 3" and "CARD 4". Each game area is played separately.
4. (a) Each ticket in scratch-off game number 2164 shall contain a total of one hundred thirty (130) play symbols.

(c) The game play data area of each ticket in scratch-off game number 2164 shall be divided into six (6) distinct game areas as follows:

- (1) An area labeled "CALLER'S CARD" that contains twenty-four (24) play symbols;
- (2) An area labeled "BONUS NUMBERS" that contains six (6) play symbols; and
- (3) Four (4) separate game areas labeled as "CARD 1", "CARD 2", "CARD 3" and "CARD 4" that contain twenty five (25) play symbols in each play area.

5. The:

- (1) retailer validation code;
- (2) game/pack/ticket number; and
- (3) validation number;

that appear on each ticket in scratch-off game number 2164 are for Commission or retailer use only and cannot be used or played as a play or prize symbol to win a prize.

6. (a) To play a ticket in scratch-off game number 2164, the ticket must be validly purchased and the scratch-off material covering the game play data area must be fully removed.

(b) If a ^{WIN}"~~WIN~~\$50" (WIN) play symbol is revealed in the "CALLER'S CARD" or in the "BONUS NUMBERS" play areas, then the ticket may be redeemed for fifty dollars (\$50).

(c) A prize is also won if the play symbols revealed in the "CALLER'S CARD" or the "BONUS NUMBERS" play areas match the play symbols in any of the "CARD 1" through "CARD 4" play areas and the matching play symbols, when combined with any "FREE" spaces in any of the "CARD 1" through "CARD 4" play areas, form any of the following patterns:

- (1) Five (5) matching play symbols to complete a vertical, horizontal, or diagonal line. The "FREE SPACE" play symbol may be used to complete the line pattern.
- (2) One (1) matching play symbol appears in each corner to complete a four (4) corner pattern.
- (3) Nine (9) matching play symbols arranged diagonally from corner to corner in the form of an "X" pattern. The "FREE SPACE" play symbol may be used to complete the "X" pattern.

(d) If the matching play symbols or "FREE" spaces follow the pattern described in (c) (1) of this section, then the prize won will be:

- (1) Two dollars (\$2) if appearing in the game area labeled "CARD 1".
- (2) Three dollars (\$3) if appearing in the game area labeled "CARD 2".
- (3) Five dollars (\$5) if appearing in the game area labeled "CARD 3".
- (4) Twenty dollars (\$20) if appearing in the game area labeled "CARD 4".

(e) If the matching play symbols follow the pattern described in (c) (2) of this section, then the prize won will be:

- (1) Twenty dollars (\$20) if appearing in the game area labeled "CARD 1".
- (2) Fifty dollars (\$50) if appearing in the game area labeled "CARD 2".

- (3) One hundred dollars (\$100) if appearing in the game area labeled "CARD 3".
- (4) Two hundred dollars (\$200) if appearing in the game area labeled "CARD 4".
- (f) If the matching play symbols or "FREE" spaces follow the pattern described in (c) (3) of this section, then the prize won will be:
- (1) Fifty dollars (\$50) if appearing in the game area labeled "CARD 1".
- (2) One hundred dollars (\$100) if appearing in the game area labeled "CARD 2".
- (3) Five hundred dollars (\$500) if appearing in the game area labeled "CARD 3".
- (4) Twenty-thousand dollars (\$20,000) if appearing in the game area labeled "CARD 4".


