

RULES AND PROCEDURES GOVERNING THE GAME ON! 2ND CHANCE PROMOTION SUPPLEMENTAL DRAWING

The State Lottery Commission of Indiana ("Hoosier Lottery" or "Lottery"), by its Executive Director, hereby promulgates these rules and procedures ("Official Rules") governing a Game On! 2nd Chance supplemental drawing ("Promotion"), authorized pursuant to 65 IAC 1-7-1. This Promotion is open to players who become eligible for participation in accordance with the Official Rules.

A. PURPOSE

The Promotion will be conducted to have a drawing containing those entries in other Game On! 2nd Chance drawings conducted earlier in CY 2020 that were inadvertently omitted from the draw pool for the drawing that corresponded with the entry, as stated in the Game On! 2nd Chance Promotion Official Rules then in effect. A drawing will be held from a draw pool containing the above-described entries only, and will award ten (10) prizes of five hundred dollars (\$500) and ten (10) prizes of one hundred dollars (\$100).

B. DRAWINGS AND PRIZE DESCRIPTIONS

- 1. Promotion will be conducted by the Hoosier Lottery in accordance with all applicable statutes, rules and drawing procedures.
- 2. Promotion drawings will occur on or about the following dates for the listed prizes (all times Eastern):

C. ELIGIBILITY

- 1. This Promotion is open to players eighteen (18) years of age or older who have a current **myLOTTERY** account in good standing.
- 2. A player may not independently enter the Promotion. Entries in the Promotion will consist of certain entries made between March 3, 2020 and August 24, 2020 into Game On! 2nd Chance Promotions that were inadvertently omitted from the respective draw pools.

3. Other eligibility regulations contained in the Official Rules for the Game On! 2nd Chance Promotion in effect at the time the player made the entry will be enforced as appropriate.

D. HOW TO ENTER

1. The Hoosier Lottery will transfer the affected entries into a new draw pool. Players may not independently enter this Promotion.

2. The non-winning tickets which a claimant originally entered into a Game On! 2nd Chance Promotion **are not required** to be retained. The claimant will be required to complete a claim form and other paperwork as required by the Hoosier Lottery.

3. Each entry must contain current and valid information. The Hoosier Lottery will not change or update entry information for an entry that has already been submitted.

E. ODDS OF WINNING

The odds of winning any prize are dependent upon the number of entries in the pool.

F. WINNER ANNOUNCEMENT AND CLAIMING OF PRIZE

- 1. Winning entries drawn for this Promotion will be notified in writing via email and/or via phone if phone number is provided. Winners who fail to complete and return all requested forms within ten (10) business days will automatically forfeit the prize and the next alternate will be selected.
- 2. Upon timely presentation of winner information, the entry will be validated and eligibility will be verified as described in Section C ("Eligibility").
- 3. If an entry is disqualified, the next alternate will be contacted by Hoosier Lottery. Alternates have ten (10) business days to respond. If all alternate entries are exhausted after the Lottery follows the process in this Section F(3), the corresponding prize will be forfeited and will not be awarded.
- 4. After Winner Verification and Winner Authorization are complete, winner information will be posted on hospital.org/hospital.org/hospital.org/hospital.org/hospital.org/
- 5. Prizes may be claimed by mail or at a Hoosier Lottery office.
- 6. Prizes awarded during this Promotion are not transferable or assignable.
- 7. Each Promotion winner may be required to participate in publicity and marketing efforts. Examples include an interview with Hoosier Lottery individuals, television, radio and/or newspaper reporters and/or photographers/videographers. This information may be used in future media, the Hoosier Lottery's website, in store Point of Purchase materials or other marketing efforts without consent or notice.

G. GENERAL RULES AND PROVISIONS

- 1. The rules and procedures set forth in these Official Rules shall govern this Promotion. These rules may be amended at any time by the Hoosier Lottery without advance notice.
- 2. The Executive Director or her designee may, at any time, announce a suspension or termination of this Promotion without advance notice and in the Executive Director's sole discretion, at which point no additional Prizes shall be awarded. The Hoosier Lottery, the Executive Director, and any employee of the Hoosier Lottery, IGT Indiana or member of the State Lottery Commission of Indiana, shall not be liable for any such termination.

- 3. By participating in the Promotion each person agrees to comply with and abide by Indiana law, rules, and regulations as well as the terms and conditions of the Lottery website and all final decisions, policies, or procedures of the Hoosier Lottery in relation to the conduct of this Promotion. Disputes related to this Promotion shall be governed by the laws of Indiana.
- 4. The Hoosier Lottery and its agents are not responsible for error, omission, interruption, deletion, defect, delay in operations, theft or destruction, unauthorized access to or alterations of entry materials, failure to receive entry, winner information, or other contest information for any reason whatsoever.
- 5. The Hoosier Lottery is not responsible for issues with **myLOTTERY** account accessibility or Promotion entries due to technical problems associated to software, hardware compatibility or internet access.
- 6. By entering this Promotion, all Promotion participants agree to indemnify, hold harmless, and waive any claims against the Hoosier Lottery, including IGT Indiana, and any of their affiliates, associates, directors, officers, agents, representatives and assigns arising directly or indirectly, out of, or in any way connected with, this Promotion or the prizes awarded in connection therewith.
