


Game Number 0155 WHEEL OF FORTUNE

- 1. The name of Fast Play game number 0155 is "WHEEL OF FORTUNE".
- 2. Tickets in Fast Play game number 0155 shall sell for five dollars (\$5) per ticket, unless otherwise adjusted by temporary price reductions or other promotional activities conducted or authorized by the Commission.
- 3. (a) Each ticket in Fast Play game number 0155 shall contain a total of seventy-nine (79) play symbols, a total of eleven (11) prize symbols.
 - (b) Each play symbol is represented as follows:

A B C D E F G H I J K L M N O P Q R S T U V W X Y Z 01 02 03 04 05 06 07 08 09 10 11 12 13 14 15 16 17 18 19 20 21 22 23 24 25 26 27 28 29 30 31 32 33 34 35 36 37 38 39 40

(c) Each prize symbol is represented as follows:



- 4. (a) To play a ticket in Fast Play game number 0155, the ticket must be validly purchased from a Hoosier Lottery terminal.
- (b) If all the play symbols in any individual word match play symbols in the "YOUR LETTERS" to form a complete word, the ticket may be redeemed for a

prize in the amount represented by the prize symbol in the " " (PRIZE BOX) that is located directly beside and corresponding to the completed word. Each word is played separately.

- (c) If all five (5) of the play symbols in either of the play areas labeled as "BONUS SPIN 1" or "BONUS SPIN 2" play area match five (5) of the play symbols in the area labeled as "BONUS NUMBERS", the ticket may be redeemed for a prize in the amount represented by the prize symbol located in the middle of "BONUS SPIN" and corresponding to the matching "BONUS NUMBERS" for that SPIN. Each "BONUS SPIN" is played separately.
- 5. Fast Play game number 0155, "WHEEL OF FORTUNE," is not cancellable once printed.
 - 6. (a) The odds for each prize level are as follows:

- 7. For a Fast Play ticket to be validated, all of the following must be met: (1) The ticket must be printed on paper stock which was validly issued to and used by the terminal from which the ticket was printed at the time of purchase;
- (2) The ticket has not been altered, torn, misprinted, found to be illegible, defaced, or damaged in such a manner that validation is impossible;

- (3) The ticket is not counterfeit in whole or in part;
- (4) The ticket has not been reconstituted or tampered with in any manner;
- (5) The typeface and artwork of play symbols, captions, or characters used as play selections must correspond with the typeface and artwork of play symbols or characters established by the Commission in these approved Game Rules, working papers, or other specifications applicable to the play of game number 0155;
- (6) Each play symbol or character must be present in its entirety and fully legible or the ticket must be capable of being validated via the ticket barcode or transaction number as printed on the ticket; and
- (7) The ticket must pass any additional validation test prescribed by the Commission, which for security reasons may be confidential in nature.
- 8. Tickets for Fast Play game number 0155 are drawn from a constantly replenished statewide pool of winning and non-winning outcomes based on the established odds. When an outcome, winning or non-winning, is randomly selected from the pool, it is then immediately replaced so the pool size and chance to win each prize remains the same for each ticket.
- 9. The Wheel of Fortune 2nd Chance Promotion Rules adopted by the Hoosier Lottery on July 13, 2023, are hereby incorporated by reference and shall govern the conduct of the Wheel of Fortune 2nd Chance Promotion from the Hoosier Lottery. - 10. Tickets expire 180 days from date of purchase and cannot be redeemed after this date.
